
In the case of the Interior map at least two versions occur which we have now initially labelled Type A with the Edinburgh circle on the centre line East/West and Type B with the Edinburgh circle centred in the lower half of the map. Images of each Type are shown below for comparison. While the text surrounding the maps appears to be the same the layout changes with each map Type.

We hope to have more information on these variations available in a future Addenda update.
