#### AMENDMENTS TO THE POSTAL LAWS AND REGULATIONS.

RAILROADS CARRYING MAILS UNDER CONTRACT.

Order No. 1938.

DECEMBER 12, 1908.

Postal Laws and Regulations of 1902 are hereby amended so as to emit Section 1333 14.

DEPOSIT OF MAIL MATTER NOT TO BE SOLICITED.

Order No. 1961.

DECEMBER 22, 1908,

Section 555, Postal Laws and Regulations, is hereby amended to read as follows:

Section 555. Postmasters must not solicit the mailing of matter at their offices by persons living or doing business within the delivery of another post office.

2. All postmasters at post offices of the fourth class are hereby instructed not to claim credit for the cancellations of postage stamps on matter diverted from other post offices to their post offices for mailing, and they will report to the Department (Office of the Third Assistant Post-master General), all such cases coming to their knowledge. The report should show the amount of postage stamps canceled on such diverted matter and the names and addresses of the senders thereof.

3. Violations of this regulation will be regarded as cause for removal.

#### REPORTS OF SPECIAL DELIVERY BUSINESS.

Order No. 1962.

DECEMBER 28, 1908.

Ordered, That Section 795 of the Postal Laws and Regulations, 1902, be amended to read as

Reports of the special delivery business transacted at city delivery offices shall be made annually on the first day of July to the First Assistant Postmaster General (Division of City Delivery) and must include all the business done during the preceding fiscal year ending on June 30th. These reports will be made on revised card Form 3952, which will be furnished upon requisition to the Fourth Assistant Postmaster General (Division of Supplies).

Order No. 1950.

#### "SANTA CLAUS" LETTERS.

Complaints having been received from many charitable organizations of abuses of the privilege extended in Order No. 934, dated December 13, 1907, permitting the delivery to such organizations of letters addressed to "Santa Claus," the privilege will not be renewed at this time. Letters so addressed should be treated as provided in Sections 625 and 681, Postai Laws and Regulations.

#### ENDORSEMENT OF LETTERS RETURNED TO WRITERS.

DECEMBER 21, 1908.

The attention of postmasters is called to Section 676 and to Paragraph 7 of Section 672, Postal Laws and Regulations, with which they should comply strictly.

The following orders and instructions were issued from the bureau of the Second Assistant Postmaster General - Joseph Stewart, Second Assistant:

#### REDUCED RATE OF POSTAGE ON LETTERS BETWEEN THE UNITED STATES AND GERMANY.

Order No. 1942.

DECEMBER 14, 1908.

Pursuant to a special agreement between this Department and the Postal Administration of Germany, it is hereby ordered, that, commencing on January 1, 1909, the postage rate applicable to letters mailed in the United States for Germany and dispatched by sea direct and not via England or France shall be two cents an ounce or fraction of an ounce. When such letters are unpaid or short-paid the deficient postage shall be collected on delivery at double the above rate.

Letters for Germany shall not be dispatched via England or France of the above rate even though specially addressed to be so dispatched. (Sec. 693, par. 15, P. L. & R., for forwarding specially-addressed letters is hereby amended accordingly.)

This order applies only to letters mailed in the States and Territories of the United States, including Alaska, on the mainland of North America, and does not extend to letters mailed in Hawali, Porto Rico, The Philippines, or other possessions of the United States.

### INSTRUCTIONS TO POSTMASTERS.

DECEMBER 25, 1908.

The reduced postage rate for letters exchanged between the United States and Germany - 2 cents an ounce for letters mailed in the United States and 10 pfennigs for each 20 gramms for letters mailed in Germany - by direct ocean transportation applies only to letters despatched by steamers able to carry such letters from the United States to German ports and vice versa. It does not, however, supersede the Postal Union rate for letters to and from Germany, for the latter rate is still applicable to letters transshipped and forwarded via England or France.

In view of the fact that there are, consequently, two postage rates for letters exchanged with

Germany, the following principles should be observed by postmasters:

1. Letters specially addressed by the sender are to be despatched and rated for postage in accordance with said special address except that letters prepaid or short-paid at the rate of postage for direct ocean transportation or at a less rate, shall NOT be despatched by OTHER THAN direct ocean transportation.

2. Letters NOT specially addressed by the sender are to be despatched:

a. In the event of prepayment, either in full or in part: when the amount of the postage prepaid is in excess of the rate of postage for direct ocean transportation, they are to be despatched by the most rapid route, i. e., via England or France; otherwise, by means of direct ocean transportation.

b. In the event of being wholly unprepaid, they are to be always despatched by means of

direct ocean transportation.

In the cases under "a," where the amount of postage prepaid is not sufficient for the route which it indicates shall be employed, double the amount of the deficiency of the

postage for such route will be collected.

3. Letters which ought to be despatched by means of direct ocean transportation, according to the principles of 1 and 2, and are erroneously despatched by another route by a post office of the country of origin, are not subject, when the postage prepaid is sufficient for the direct ocean route, to the payment of any additional postage, and in any other case they are to be rated up only at the postage rate for direct ocean transportation.

As far as postage is concerned, these instructions apply to registered as well as ordinary letters. Deficiencies in postage and registry fees on registered letters received at exchange post offices for despatch to Germany will be supplied as heretofore as required by Section 959, Postal Laws and

Regulations, 1902.

The new Agreement does not provide for a corresponding reduction in the rate for post cards which remains two cents per card as heretofore.

#### PARCEL POST WITH GERMANY.

Order No. 1946.

DECEMBER 15, 1908.

Order No. 1865, dated November 10, 1908, is hereby modified so as to read as follows:

The Postal Administration of Germany having concurred therein, it is hereby ordered, that no parcei the value of which exceeds fifty dollars shall be admitted to the parcel-post mails from Germany for the United States. Parcels shall be admitted to the parcel-post mails from the United States for Germany, however, without regard to the value thereof.

#### PARCEL POST WITH MEXICO.

DECEMBER 2, 1908.

Referring to the circular dated December 29, 1898, on page 1107 of the United States Official Postal Guide for January, 1899, relative to parcel-post packages for Mexico: United States postal officials are informed that the Postal Administration of Mexico has advised this Department that parcels weighing up to eleven (11) pounds (5 kilograms) may be sent to the following Mexican post offices, viz:

Baluarte Estacion ......State of Coahulla, 

Consequently, parcel-post packages weighing not more than eleven pounds may be accepted for mailing to the Mexican post offices above named as well as to the Mexican post offices named on pages 139-142 of the United States Official Postal Guide for July, 1908.

#### NEW ZEALAND AND AUSTRALIA - MAILS FOR.

DECEMBER 11, 1908.

For the future mails for New Zealand and Australia (except West Australia) will be dispatched by steamers of the Oceanic Steamship Company salling every 36 days from San Francisco for Papeiti, to connect at Papeiti with steamers of the Union Steamship Company sailing thence for Wellington, New Zealand; the new service to be inaugurated with the sailing from San Francisco on the 28th lustant of the steamer Mariposa. The dispatches described will be in addition to those now being made from San Francisco by the Australian Mall Line and from Vancouver by the Canadian Line.

The following instructions were issued from the bureau of the Third Assistant Postmaster General - A. L. Lawshe, Third Assistant:

#### NEW POSTAGE STAMPS.

DECEMBER 23, 1908.

Postmasters are notified that the Department is now prepared to furnish the following postage stamps of the new series of 1908:

One cent (green) and 2c. (red) in sheets and in books; 3c. (purple), 4c. (brown), 5c (dark blue), Sc. (olive), and 10c. special delivery.

#### DESCRIPTION OF SPECIAL-DELIVERY STAMP.

Size, 1.01 by .84 inch; color, green. In the upper left corner is the denomination, 10, in figures inclosed in a circle. Running diagonally from the lower left corner appears an olive branch entwining the winged hat of Mercury. In the lower right-hand portion of the stamp is the inscription "U. S. Postage. Special Delivery," in a rectangular panel.

The new special-delivery stamp will be issued in sheets of 70 instead of 50 as formerly, and requisitions should always be made for 70 or a multiple of 70, except that postmasters who cannot sell so many as 70 within two years may make requisition for 10.

The new stamps as they are ready will be issued upon all requisitions drawn on Form 3201, except that requisitions calling for more than one full package of 10,000, 50,000 or 200,000 stamps of any denomination may be filled in part with stamps of the 1902 series until the Department's supply of the old stamps is exhausted.

Postmasters must not return to the Department any undamaged stamps of the old series. They should be placed on sale until exhausted, but the new stamps should be supplied when preferred

Requisitions for the new stamps should not be made for less than the quantities usually ordered, as it is desired to avoid frequent requisitions. In making out requisitions postmasters should be guided, so far as possible, by the instructions on page 8 of the October supplement to the 1908 Postal Guide.

#### STAMPS IN ROLLS.

DECEMBER 23, 1908.

The Department is now prepared to issue limited quantities of postage stamps in rolls of 500 or 1,000, for use in stamp-vending and stamp-affixing machines. The stamps will be coiled on paper cores one-half inch in diameter. To secure stamps in this form postmasters will make requisition on Form 3201, and attach to it a letter stating:

- 1. Whether the stamps are desired for use in a stamp-vending or stamp-affixing machine.
- 2. Whether the stamps are desired in coils of 500 or of 1,000 stamps each.
- 3. Whether the strips should be arranged with the stamps endwise or sidewise.
- 4. Whether the blank margin between the stamps should be perforated or unperforated.

#### FOUR CENT NEWSPAPER WRAPPERS EXHAUSTED.

DECEMBER 23, 1908.

Postmasters are notified that the manufacture of four cent newspaper wrappers has been discontinued and the Department's stock is now exhausted. They are still good for postage, however, and those remaining in stock in post offices should be kept on sale. Undamaged wrappers must not be sent to the Department for redemption.

#### INVALID DOMESTIC MONEY ORDERS.

The Auditor for this Department has called attention to the fact that large numbers of invalid domestic advices are received unaccompanied by Form 6686, as required by Section 1132, Postal Laws and Regulations. Such carelessness on the part of postmasters results in the performance of much labor in the office of the Auditor which would otherwise be unnecessary.

It is important that postmasters at money order offices promptly forward to "The Auditor for the Post Office Department, Washington, D. C.," monthly statements (Form 6686) on which are listed all advices of unpaid invalid domestic money orders, and that such advices accompany the list. See in this connection Section 1035, Postal Laws and Regulations. It is especially necessary, in order that the work of the Auditor may be facilitated, that postmasters comply strictly with the requirements of the sections above mentioned.

#### DISCONTINUANCE OF THE POST OFFICE REGISTRY TRANSFER STATION AT KANSAS CITY, MO.

Because of the establishment of a Terminal R. P. O. at Kansas City, Mo., effective December 15, 1908, the separate registry transfer station heretofore attached to the Kansas City. Mo., post office will be discontinued. Postmasters are therefore instructed to cancel the words "Kansas City, Ma." in the list in paragraph 60 on page 66 of the July, 1908, Postal Guide, showing the names of post offices having separate stations for handling transit registered mail.

#### CHANGE IN SCHEME OF DISPATCH OF REGISTERED MAIL TO MEXICO, DIS-CONTINUANCE OF SAINT LOUIS, MO., AND ESTABLISHMENT OF CHICAGO, ILL., AS EXCHANGE OFFICE.

DECEMBER 8, 1908.

Instructions have been issued for the discontinuance of Saint Louis, Mo., as an office authorized to exchange registered mail with Mexico, and for the establishment of Chicago, III., as a Mexican exchange office. As a result of the discontinuance of Saint Louis, Mo., as an exchange office for Mexico, registered matter for Mexico formerly sent to that office will be dispatched to Chicago, III., or Laredo, Tex., as may be proper under the following instructions, these instructions to be effective on and after January 18, 1909:

### CHANGES IN DISPATCHES OF INTERNATIONAL AND OF DOMESTIC THROUGH REGISTERED POUCHES.

DECEMBER 22, 1908.

The following changes in dispatches of international through registered pouches will become effective on January 18, 1909:

The exchange between Saint Louis, Mo., and Mexico City, Mexico, will be discontinued. The exchange between Saint Louis, Mo., and Nuevo Laredo, Mexico, will be discontinued, An exchange between Chicago, III., and Mexico City, Mexico, will be established. An exchange between Chicago, Ill., and Nuevo Laredo, Mexico, will be established. An exchange between Laredo, Texas, and Nuevo Laredo, Mexico, will be established.

Consequent upon the foregoing, the exchange of through registered pouches between Saint Louis Mo., and Laredo, Texas, will be discontinued, and an exchange of through registered pouches between Chicago, Ill., and Laredo, Texas, will be established; effective January 18, 1909.

The following instructions were issued from the bureau of the Fourth Assistant Postmaster General - P. V. DeGraw, Fourth Assistant:

## PROMPT PAYMENT OF PREMIUMS ON BONDS OF RURAL CARRIERS.

Attention is called to the notice which appeared in the June Supplement to the January, 1908, Postal Guide, relative to complaints made to the Department by bonding companies, that many rural carriers and substitute rural carriers fail to promptly pay the premiums on their bonds as they become due, and that a large number are in arrears in the payment of their premiums.

As these complaints still continue to be made to the Department, postmasters are directed to at once notify all rural carriers and substitute rural carriers under their supervision, who are bonded by bonding companies, that it is positively necessary to keep the premiums on their bonds paid up. and that, if they desire to retain their positions in the service, all arrears on the premiums must be paid at once.

Postmasters will make inquiry and report to the Department the names of all delinquents.

### DEPOSIT OF MONEY IN RURAL MAIL BOXES FOR THE PURCHASE OF MONEY ORDERS SHOULD BE DISCOURAGED.

It has come to the notice of the Department that it is the practice of some patrons of rural delivery to deposit money for the purchase of money orders in rural mail boxes, and without being accompanied by the written application therefor, as required.

Postmasters and rural carriers are directed to discourage this practice, but postmasters will require carriers to take up money found in boxes, and make out application for the patron according to directions, and present to postmaster, who will issue the order according to directions.

Postmasters in returning receipts to patrons should enclose a note advising that in order to avoid possibility of loss, patrons should transact money order business with the carriers personally, and should fill out and sign the required application. Postmasters should also enclose patrons one or two blank applications for money orders for future use.

Postmasters and rural carriers should see that the provisions of Chapter 10, relating to money order business on rural routes, which appears in the Instructions for the guidance of postmasters and carriers in the conduct of the Rural Delivery Service, are carefully observed.

# PAMPHLET OF GENERAL POSTAL INFORMATION

The new edition of the Pamphlet of General Postal Information is now ready for distribution and all postmasters are directed to see that each teacher in the public, private and commercial schools within the delivery of their respective post offices is supplied with one copy. It is intended that the distribution of the new edition of the pamphlet be limited as nearly as practicable to the school teachers.

Attention is invited to the last cover pages of the October, November, and December, 1908, Postal Guides. Requisition for the Pamphlet should be made on the Fourth Assistant Postmaster General, Division of Supplies, and the number of teachers to be supplied should be stated.

# MODEL FORM OF ADDRESS FOR LETTERS

Postmasters are directed to furnish to each family within the delivery of their respective offices a copy of form No. 7959—Model Form of Address for Letters—requisition for which should be made upon the Fourth Assistant Postmaster General, Division of Supplies.

These cards should be distributed by postmasters through post office boxes and general delivery windows; through city letter carriers to patrons in their districts; and through rural carriers to patrons on rural routes by depositing in rural boxes one for each family.

Postmasters should see that all schools are provided with a limited supply of this form.
