## AMENDMENTS TO THE POSTAL LAWS AND REGULATIONS.

FRANKING PRIVILEGE GRANTED TO RESIDENT COMMISSIONERS ELECTED BY PHILIPPINE LEGISLATURE.

Order No. 5146.

DECEMBER 6, 1910.

Ordered, That in accordance with the provisions of the Act of Congress approved June 14, 1910, extending the franking privilege to the Resident Commissioners to the United States elected by the Philippine Legislature, Section 506 of the Postal Laws and Regulations be amended by the adoption as paragraph 2 of the following:

2. Resident Commissioners to the United States (elected by the Philippine Legislature) shall \* \* \* be allowed \* \* \* the franking privilege now enjoyed by members of the House of Representatives. (Act of June 14, 1910, Ch. 291, P. 467, Vol. 36, Stat. L.)

#### RETURN OF UNCLAIMED MATTER.

Order No. 5156.

DECEMBER 13, 1910.

Item (b), paragraph 1, Section 672, of the Postal Laws and Regulations, as amended November 8, 1910, by Order No. 5074, is hereby further amended to read as follows:

(b) Uncalled-for letters for general delivery in cities, ten days.

## TRANSFERS OF SPECIAL AGENTS AND ASSISTANT SUPERINTENDENTS.

Under date of December 1, 1910, the Postmaster-General issued orders numbered 5130, transferring the assistant superintendents of the Division of Salaries and Allowances, and 5131, transfering the special agents of the Division of Classification and the assistant superintendents of the Division of Registered Mails, from the bureaus of the First and Third Assistant Postmasters-General respectively, to the office of the Postmaster-General, and hereafter these officials will be under the immediate supervision of the Chief Inspector.

### SPECIAL PRIVILEGES EXTENDED TO AGENTS OF DEPARTMENT OF JUSTICE.

NOVEMBER 30, 1910.

By order of the Postmaster-General dated November 23d, L. M. Terrell, Superintendent Fourth Division of Railway Mail Service, was transferred from the office of the Second Assistant Postmaster-General to the office of the Postmaster-General; George W. Pepper, Superintendent of the Ninth Division of Railway Mail Service, was transferred to the Fourth Division, and Clyde M. Reed was appointed Superintendent of the Ninth Division of Railway Mail Service.

All persons interested will take due notice of these changes and govern themselves accordingly.

#### MEXICO.

#### PARCEL-POST PACKAGES.

NOVEMBER 26, 1910.

The Postal Administration of Mexico has advised this Department that, commencing November 21, 1910, parcels weighing up to cleven (11) pounds (5 kilograms) may be sent to the Mexican post-office of Banderilla, State of Veracruz.

Consequently, parcel-post packages weighing not more than eleven pounds may be accepted for mailing to the Mexican post-office above mentioned, as well as to the Mexican post-offices named on pages 225-228 of the United States Official Postal Guide for July, 1910.

#### FIRE-ARMS PROHIBITED.

DECEMBER 15, 1910.

This Department has been advised by the Postal Administration of Mexico that the President of that Republic has made an order prohibiting in general the importation by mail of arms and ammunition of any kind for any place in Mexico, and the Mexican exchange offices have been instructed to return to origin any arms and ammunition which may be contained in mails received at those offices from other countries.

Paragraphs (c) and (f) of Section 64, on page 209 of the Postal Guide for July, 1910, have been modified accordingly, and postal officials will cause proper notice of the same to be taken.

## SHORT-PAID LETTERS FOR FOREIGN COUNTRIES.

NOVEMBER 29, 1910.

The Department is advised that many letters mailed in the United States addressed for delivery in foreign countries, which are subject to our Postal Union postage rate, are prepaid only two cents, the senders of the letters being under the impression, it is presumed, that our two-cent domestic postage rate is applicable to said letters.

The only foreign countries to which the two-cent letter rate applies are Canada, Cuba, Mexico, Newfoundland, the Canal Zene, the Republic of Panama, Germany (by direct steamers only), England, Scotland, Wales and Ireland, and the city of Shanghal, China. To all other countries the rate is five cents for the first ounce or fraction thereof, and three cents for each additional ounce or fraction thereof, which must be fully prepaid or the letters become liable on delivery to a charge equal to double the amount of the deficient postage. For instance, a single-rate letter prepaid only two cents would be subjected on delivery to an additional postage charge of six cents.

As charges for postage due on short-paid letters give rise to much complaint, postmasters are directed to caution the patrons of their offices respecting the matter and to give this notice the widest publicity possible.

# ARTICLES FOR THE FAR EAST VIA SIBERIA.

NOVEMBER 23, 1910.

Postal officials are advised that letters and postal cards, ordinary and registered, destined for the Far East, including Siberia, Manchuria, Korea and China, which are specially addressed upon the covers "Via Siberia" or "Via Europe-Siberia," should be dispatched in accordance with the special address.

Said specially-addressed letters and postal cards are to be included in mails for Germany, whence they will be forwarded via Russia and the Siberian Railway, provided the word "Siberia" appears plainly in the address above indicated.

# MAILS FOR YUNNAN PROVINCE, CHINA.

DECEMBER 2, 1910.

Postmasters are instructed that, commencing December 10, 1910, articles addressed for delivery to destinations, except Bhamo and Tengyueh, in the Province of Yunnan (Junnan), China, should

be placed in packages labeled "Transpacific-Foreign" and forwarded for dispatch from San Francisco and Seattle. Articles for Bhamo and Tengyueh should continue to be dispatched via New York. The "General Foreign Separating Scheme" on page 218 of the Postal Guide for July, 1910, should be modified accordingly.

## POSTAL SAVINGS SYSTEM.

# OFFICIAL ADHESIVE AND EMBOSSED POSTAGE STAMPS.

DECEMBER 29, 1910.

Postmasters and others in the postal service are notified that special stamps and stamped envelopes have been provided for official mail matter relating to the Postal Savings System, under the following provision of the Act of Congress approved June 25, 1910, establishing postal savings depositories:

" Sec. 2. That the Postmaster-General is hereby directed to prepare and issue special stamps of the necessary denominations for use, in lieu of penalty or franked envelopes, in the transmittal of free mail resulting from the administration of this Act."

The official stamps and stamped envelopes are described as follows:

Adhesive stamp. This stamp is a rectangle on end, of the same size as the ordinary postage stamp. The color is black. In the center is an ellipse containing the words "Official Mail" in white letters, the background within the ellipse being lathe work. Outside of and following the curve of the ellipse are the words "U. S. Postal Savings" in white letters. In each lower corner is a numeral expressing the denomination, and between these numerals the word "Cents" appears in white letters. In the corners at the top are small triangular panels containing relief work.

Stamped envelopes. The embossed stamp is an ellipse on end. The color is red. In the center in plain gothic type appear the words "Official Mail" in two horizontal lines. In the upper half of the border are the words "U. S. Postal Savings," and in the lower half "Two 2 Cents," the numeral 2 being prominent.

# SUSPENSION OF MONEY ORDER BUSINESS WITH CERTAIN MEXICAN POST OFFICES.

JANUARY 3, 1911.

This Department has received telegraphic notice from the Mexican Postal Administration of the temporary suspension of money order business at the following named offices, all situated in the state of Chihuahua:

Therefore, until otherwise instructed, postmasters at money order offices in the United States after receipt of this notice, will decline to issue money orders payable at any of the offices above named, and will withhold payment of any orders issued thereat on or after December 29, 1910, advising the holders to return them to the remitters.

# MONEY ORDERS PAYABLE IN NEWFOUNDLAND.

DECEMBER 28, 1910.

The attention of postmasters is invited to the fact that, in the issue of money orders, on the domestic form, for payment in Newfoundland, a separate advice, on form 6006, must invariably be dispatched to the postmaster at Sydney, N. S. Canada, in each case, and not to the office of payment in Newfoundland.

It is enjoined upon postmasters to see that this essential requirement be not disregarded.

# INQUIRIES OR REQUESTS CONCERNING MONEY ORDERS ISSUED AT NUMBERED STATIONS.

DECEMBER 23, 1910.

Postmasters are informed that hereafter inquiries or requests which they may, have occasion to make concerning money orders issued at aumbered stations, should be addressed to main offices and not to such stations.

# REGISTRY DISPATCHES AND EXCHANGES TO BE LABELED TO PENNSYLVANIA TERMINAL R. P. O., NEW YORK, N. Y., INSTEAD OF TO PENNSYLVANIA TERMINAL R. P. O., JERSEY CITY, N. J.

DECEMBER 13, 1910.

Because of the discontinuance of the Pennsylvania Terminal R. P. O., at Jersey City, N. J., and the establishment in lieu thereof of the Pennsylvania Terminal R. P. O. at New York, N. Y., the through-pouch and inner-sack exchanges and dispatches of registered mail heretofore authorized to be made to and from the Pennsylvania Terminal R. P. O., Jersey City, N. J., are hereby authorized to be made to and from the Pennsylvania Terminal R. P. O., New York, N. Y.

# FAILURE TO FURNISH REGISTRY RETURN RECEIPTS WHEN DESIRED.

DECEMBER 23, 1910.

Frequent complaints are being received at the Department concerning failure of senders of registered mail to receive return receipts therefor as requested by proper endorsement on the envelopes or wrappers of such mail.

Postmasters at both mailing and delivering offices are expected to carefully inspect all registered mail to ascertain if return receipts are desired by the senders, and to furnish the receipts, when desired, in accordance with the amendment to Sections 811, 852 and 855 of the Postal Laws and Regulations, and the instructions thereunder printed on pages 5, 6, 12 and 13 of the August, and on the inside of the cover of the November, 1910, Postal Guides.

The following notice was issued from the bureau of the Fourth Assistant Postmaster-General-P. V. DeGraw, Fourth Assistant:

## NOTICE TO POSTMASTERS AT CITY DELIVERY OFFICES.

The attention of this Bureau has been called to the fact that numerous monthly reports, Form F. D. 2, indicating the number of street letter boxes in use, are incorrectly mailed to the First Assistant Postmaster-General, Division of City Delivery. It is, therefore, directed that this practice be discontinued at once, and that all future reports on the form mentioned be mailed to the Fourth Assistant Postmaster-General, Division of Supplies.

# DISCONTINUANCE OF REGISTERED PACKAGE AND TAG ENVELOPES ON AND AFTER JANUARY 1, 1911

Special attention is directed to the Postmaster-General's Order No. 5113, dated November 25, 1910, printed on page 5, and to the detailed instructions from the office of the Third Assistant Postmaster-General, printed on pages 7 and 8, of the December, 1910, Postal Guide, concerning the discontinuance of registered package and tag envelopes at all post offices in the preparation of registered mail for dispatch, on and after January 1, 1911.

# Treatment of Spoiled and "Not Issued" Money Order Forms.

December 23, 1910.

Instructions given in the third paragraph on page 2 of Circular No. 6384, dated July 12, 1910, relative to new-style domestic money orders, are modified to read as follows:

"The order should not in any case be handed to the remitter until the issuing official is quite sure that it has been drawn for the right amount. Be very careful to see that the order has been correctly separated from the stub. Do not attempt to correct a mistake made in order or coupon or receipt by writing over the erroneous words or figures, but in case a mistake has been made, and is discovered before delivery of the order to the applicant, or before the order has been taken from the post office or its issue made an item of account, treat order, with corresponding coupon and receipt, as spoiled and not issued, issue a new order without additional charge, and send the spoiled order (but not the coupon or receipt) with the next Statement to the Auditor in accordance with Sections 988 and 1000 of the Postal Laws and Regulations, after writing across its face the words 'Not issued.' The same words should be written on the face of the spoiled coupon and stub, both of which should be retained at the post office. The coupon should be filed with the coupons of paid and repaid orders; the stub should be left in its own place between the covers; the receipt form should be destroyed. for use because of defective printing, mutilation or defacement, should be treated in the same manner; the order should be sent to the Auditor, the coupon and stub should be retained at the post office, the receipt form should be destroyed."

In order that the Auditor's Office may not be encumbered with coupon and receipt forms, strict compliance with that portion of the foregoing which relates to treatment of spoiled, defective and mutilated or defaced forms is hereby specially enjoined upon postmasters.
